Updates: <u>Partial Resumption of the Manufacturing Activities at our Factories at Mumbai, Chhatral,</u> <u>Pashamylaram, Distt-Medak and Lucknow and Partial opening of few Depots and Partial Resumption</u> <u>of Despatches</u>

Dear Sir,

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation of our letter dated 21st March, 2020, as we fall under the Essential Services Sector, we wish to inform the Exchange as under:

- 1. that Manufacturing Activities(with minimum number of workforce) at our Factories at Mumbai(Maharashtra), Chhatral(Gujarat), Pashamylaram, Distt-Medak(Telengana) and Lucknow(U.P.), have partially resumed.
- 2. that few of our Depots(with minimum number of workforce) have partially opened.
- 3. that the Despatches from all these above referred Factories and Depots have partially resumed, subject to availability of Logistics(Inbound and Outbound).

Well-being of its employees is of utmost importance to the Company and hence the Company has put in place requisite safety measures for employees working at all the above mentioned places which are in line with the directives issued by the Government of India, State Governments and Local Authorities to combat COVID-19.

The situation will be continuously reviewed in view of the ongoing directions of the State and Central Government and the Local Authorities and depending on the situation prevailing in the Local areas of all our locations, we will review the continuation/stoppage of all or part of the above activities, and act accordingly. Further, we will update the Exchanges on full resumption of all our activities, post lifting of the Lockdown.

Our Corporate Office is still closed. However, all employees and Officers at Senior level continue to work from home.
